  2. To secure a sale position the following must be submitted: (1) consignment form, (2) copy of the registration paper, (3) consignment fee (by check or credit card), (4) e-mail or fax an owner's informational statement about the horse.
  3. Individual negative coggins test within 6 months of sale date and a current health certificate is required for each horse.
  4. A signed breeder's certificate must be given to the new buyer on all bred mares and mares with foals at their sides.
  5. Mares selling in foal must be pregnancy tested by a veterinarian between September 5 – September 22.
  6. Photos (5 maximum) and video (3-minute maximum) or YouTube video link must be submitted by August 25.
  7. Horses consigned as unsound in eyes or wind (windsuckers), cribbers, weavers, lame or those who are breeding sound only must be designated at time of consignment.
