5. Horses consigned as unsound in eyes or wind (windsuckers), cribbers, weavers, or those who are breeding sound only must be designated at time of consignment.
6. All horses sell sound unless otherwise noted.
7. A signed transfer with registration papers must be mailed to the new buyer within fourteen business days from auction.
8. Consignor must agree to the auction Terms & Conditions located on [www.usahorseauctions.com](http://www.usahorseauctions.com).
9. No substitutions; in the event of the death of the horse, contact office.
