3. Individual negative coggins test within 6 months of sale date and a current health certificate is required for each horse.
4. A signed breeder's certificate must be given to the new buyer on all bred mares and mares with foals at their sides.
5. Mares selling in foal must be pregnancy tested by a veterinarian within 10 days of auction and verified with the Auction office.
6. Photos (5 maximum) and video link must be submitted by the consignment deadline.
7. Horses consigned as unsound in eyes or wind (windsuckers), cribbers, weavers, lame or those who are breeding sound only must be designated at time of consignment.
8. Consignor must read and agree to the auction Terms & Conditions located on www.usahorseauctions.com.
9. Substitutions; contact office.
